
# ANNUAL REPORT 2016-17

#### **ACCOMPLISHMENTS**

#### **ECONOMIC JUSTICE**



The Dignity at Work Coalition is entering its third year of collective advocacy for policies that promote sustainable work that allows for sustaining families. Wisconsin Faith Voices for Justice is the backbone organization that supports this work, along with the member organizations on our Steering Committee – 4-C, 9to5 Wisconsin, Dane County NAACP, the Interfaith Coalition for Worker Justice, the Wisconsin Alliance for Women's Health, the Wisconsin Coalition for Retirement Security, the Wisconsin Council of Churches, Wisconsin Jobs Now.

Over the past year, the Dignity at Work Coalition has educated its member and supporting organizations on issues affecting the childcare industry and low-income childcare workers; the challenges facing retirees who have little or no pension or retirement savings; and the damaging policies to workers that are promoted in the state's 2017-19 biennium budget proposal. We have worked together, under the leadership of 9to5 Wisconsin, to advocate for paid family leave, and have educated the public on important issues in the 2016 state and federal elections.

#### Our accomplishments include:

- The 2016 Voter's Guide for Economic Justice members worked together to create a guide for voters to provide them with background and sample questions to ask their candidates on issues including funding for childcare, raising wages for childcare workers, paid sick leave and paid family leave, promoting a private sector pension fund, and promoting funding for public transportation and non-emergency medical transportation.
- Paid Family Leave (SB215/AB286): the Dignity at Work Coalition worked under the direction of 9to5 to advocate for a paid family leave bill that would expand the definition of family, lower the threshold for businesses required to participate, ensure wage replacement and job protection.
- **Speakers Bureau:** To promote our issues and policy priorities and inspire the public toward activism, we are creating a Speakers Bureau, which will bring experts from our organizations and people most impacted by our issues to speak to congregations, civic organizations, college campuses, and other venues. We appreciate the support of the South West Conference of the United Church of Christ for this important work.

### FAITH LEADERS BUILDING COMMUNITY, STANDING TOGETHER

This is a critical moment in our nation's history. Many of our communities are experiencing a palpable fear of what the present political climate will mean for them. But this is also a time of opportunity. People are galvanized to action as never before. Now, more than ever, we must join together to fight against hate, to resist attacks on our communities, and to stand united in trust and love.

In response to this new reality, WFVJ wrote a **Proclamation Against Hate** and sent a letter to the Dane County and Madison elected officials, asking them to pass resolutions in favor of this proclamation (<a href="http://wisconsinfaithvoicesforjustice.weebly.com/voices-for-justice-blog/faith-leaders-statement-against-hate">http://wisconsinfaithvoicesforjustice.weebly.com/voices-for-justice-blog/faith-leaders-statement-against-hate</a>). Ten organizations and businesses, and over 90 individuals, signed on to the letter. Dane County Executive adopted our resolution, and the Dane County Board of Supervisors and Madison Common Council passed resolutions based on our proclamation.

#### **Dane Sanctuary Coalition**

In response to the urgent request from Voces de la Frontera (<a href="www.vdlf.org">www.vdlf.org</a>), and in close partnership with Voces and Centro Hispano (<a href="www.wdlf.org">www.micentro.org</a>), WFVJ has been working throughout Dane County and beyond to educate congregations about the New Sanctuary Movement. We are currently engaged in organizing congregations that have voted to become sanctuary sites (offering physical shelter as the need arises) and sanctuary supporting congregations (providing financial, logistical, and volunteer support to the sanctuary site congregations). Five congregations thus far have voted to be sanctuary sites, and four more to be supporting congregations. We will be making a formal announcement at a press conference on July 6. #### **Interfaith Community Building Coalition**

Over the last year, our nation has seen a rise in hate crimes and threats to the Muslim, Jewish, and Sikh communities. Wisconsin Faith Voices for Justice has gathered a coalition of people



from diverse faith communities, to work together to build community, foster trust, and forge relationships among our different faith groups. We pray that this Coalition will be a locus of hope, friendship, and mutual support for all our communities of faith.

On June 10, we held our first major event – Faith, Fasting, and Friendship – an Interfaith Ramadan Break the Fast. Over 150 people of different faiths came together to learn about food and fasting in various faith traditions, and then to share a wonderful pot-luck dinner to break the Ramadan fast. A food drive for

Second Harvest Food Bank was an important part of the evening. We raised \$326 and brought in 48 pounds of food.

#### ADVOCACY WORKSHOP

From the ancient Israelite prophets crying out on street corners, to modern-day Buddhist monks immolating themselves in protest against tyranny and injustice, religious leaders and people of faith have been inspired and impelled to speak out in the public square. Social justice is a fundamental concern of most faith traditions, manifested both through service and through activism. But sometimes congregations are reluctant to engage in advocacy. Sometimes they fear violating their tax-exempt status. Some feel advocacy is not an appropriate activity for faith communities. And some are eager to get engaged, but feel they lack the skills and resources to be effective.

Our three-session workshop, Moving from Charity to Justice: A Workshop in Faithful Advocacy, dispels myths about what congregations can and cannot do in terms of advocacy and discusses how to engage the congregation is an advocacy campaign; and provides hands-on experience in writing letters to the editor or op-ed pieces; and in making a lobby visit or testifying on an issue.

The ability of congregations and people of faith to be effective advocates for a moral vision for our state and country is vital if we are to create the just and equitable world we all desire. This spring, we were able to provide the trainings to area congregations around Madison, due to the sponsorship of two local congregations. We would love to bring this workshop to your area. **PARTNERSHIPS** 

Wisconsin Faith Voices for Justice works very closely with faith communities, social service organizations, and advocacy organizations. We are indebted to all our partners for their generosity in sharing resources, materials, information, and opportunities to raise the religious voice in the public square.

- People of Faith United for Justice is a partnership of faith organizations that come
  together every other year to organize a statewide advocacy day to address moral issues in
  the biennium budget proposal. This year's issues included threats to social safety net
  programs (food stamps, BadgerCare, housing assistance); clean water; and sex
  trafficking.
- Medicaid-Matters a coalition of health care advocacy organizations led by the Wisconsin Alliance for Women's Health, which shares information, analyses of legislation, messaging, and action alerts. Our participation in this body has been invaluable in helping us keep track of the quickly-shifting landscape in health care 'reform' in the current Administration.
- NAACP Wisconsin Faith Voices for Justice has long had a close relationship with the Wisconsin NAACP. Most recently, on September 12, we partnered with the NAACP to sponsor the Moral Day of Action at the state capitol, in coordination with similar events across the country, led by Rev. William Barber.
- Rev. William Barber and Repairers of the Breach brought their Revival of Moral Values tour to Milwaukee on November 2, 2016. Wisconsin Faith Voices for Justice took part in this event, with Rabbi Margulis participating as one of the speakers.
- On January 29, 2500 people gathered at Monona Terrace to talk about how we, as a community, can join together in solidarity to fight against hate. Wisconsin Faith Voices

- for Justice was part of the organizing team. At that event, a new organization we helped to form was introduced We are Many- United Against Hate.
- Wisconsin Interfaith Light and Power and Tikkun Ha-Ir held a climate change vigil in which we participated. We also co-led our advocacy workshop at a WILP conference.
- National Voter Registration Day as part of this national effort to bring out the vote in the 2016 election, Wisconsin Faith Voices for Justice President Rabbi Margulis was trained as a volunteer registrar and WFVJ co-sponsored registration events.
