Wisconsin Faith Voices for Justice's annual celebration is always an opportunity for me to reflect on the year past, our accomplishments and challenges, and to look to the coming year with anticipation.

This past year has been one of turmoil and violence aimed at our faith communities in the U.S. and around the world, but also one of love and hope, as we have reached out to support and comfort one another. In addition to building community among faith traditions, WFVJ is also deeply involved in building coalitions centered on issues of social justice.

- ➤ The **Dane Sanctuary Coalition**, which we were instrumental in founding two years ago, has been a locus for work on immigrant justice, from direct service for undocumented individuals, to advocacy on a local and state level.
- Four years ago, WFVJ founded the **Dignity at Work Coalition**, which has become a leader in advocating for policies that make for sustainable work and in turn helps us sustain our families.

#### Our programs included:

Sanctuary organizes congregations and organizations to provide physical sanctuary to our immigrant friends and neighbors who are at risk for deportation. We do this as part of the national New Sanctuary Movement.

- > June 30<sup>th</sup> press conference on separation of families at the border
- ➤ Partnered with Voces de la Frontera on press conference to lift up the plight of undocumented immigrants Maria Portugal and Franco Ferrerya on July 24
- > Op-ed "Separating Children from Parents is Inhuman" published in The Cap Times
- ➤ Volunteer drivers recruited and trained to drive undocumented individuals to Milwaukee or Chicago for ICE check-ins and deportation hearings
- ➤ Words of Worth campaign with the Community Immigration Law Center, to send postcards to undocumented people in detention centers at the border

#### **COALITIONS**

Wisconsin Faith Voices for Justice works very closely with faith communities, social service organizations, and advocacy organizations. We are indebted to all our partners for their generosity in sharing resources, materials, information, and opportunities to raise the religious voice in the public square.

- Medicaid Matters advocacy for health care reform; preserving BadgerCare; opposing attempts to overturn and undermine the Affordable Care Act
- Public Benefits Coalition working together to preserve the social safety net, including access to affordable housing, child care, health care, transportation, education, and nutrition
- Better Budget Coalition brings together social justice organizations to advocate together for a state budget that reflects the needs and the values of all Wisconsin residents
- Transit Riders Coalition advocating for public transportation in rural and urban areas

#### BRINGING OUR WORK TO THE COMMUNITY

A central aspect of our mission is to educate our communities about the **intersection of faith** and public life; to lift up the issues that face our state and country; and to provide tools to empower people to take action. In addition to the above, we have engaged our congregations and the public in the following ways:

- ➤ Moving from Charity to Justice: A Workshop on Faithful Advocacy Temple Beth El and Christ Presbyterian Church in Madison co-sponsored our three-session workshop on how faith communities and people of faith can be effective advocates for social justice
- > Organized a focus group of faith leaders with UW Hospital and other health agencies for their annual Community Health Care Assessment
- Created and posted to YouTube a video on how to register and vote
- > Organized a training on how to register people to vote and recruited congregations to hold voter registration drives; co-sponsored another training with First Unitarian Society
- ➤ Created and disseminated over 100 **Voter Pledge Cards**
- ➤ Organized a **Know Your Rights** training with the ACLU at Centro Hispano for the immigrant community in the wake of ICE raids in Wisconsin
