Dear Friends,

I write this from the vantage point of the aftermath of the 2022 election season. Many of us went into this election with a deep fear for the future of our democracy and of our country. Fortunately, our worst fears were not realized. However, there is still much work to be done if we are to create the Beloved Community that we all want to see.

Nearly ten years after the Race to Equity Report, Wisconsin is still the worst state to raise a black child. Antisemitic incidents have threatened the Jewish community across the state. Voter suppression and partisan gerrymandering still seek to silence our voices. Anti-equity extremists agitate against racial justice and trans rights in our schools and communities. And the fallout from nearly three years of pandemic will take years to understand fully and to address.

All these challenges and more can be daunting and overwhelming. Often, I am asked what keeps me going in this work, when progress comes so slowly and sometimes it seems we are moving backward instead of forward?

My answer is simple – what keeps me going is all of you! This past year, you stood up for immigrant rights and justice. You spoke out for voting rights and fair maps. You joined our growing initiative to take a faithful stand for racial justice and create the Beloved Community of Dr. King's vision. And you worked to build bridges among people of different faiths. We could not do our work without all of you!

We also could not have done any of the work described in this report without our amazing consultants, board, many volunteers, and supporters. See within to find their names. We are immensely grateful to all of you for all your ongoing help and support!

I look forward to continuing our work together in the year ahead!

The Wisconsin Interfaith Voter Engagement

Campaign (https://wivec.wichurches.org/), co-led by WFVJ and Wisconsin Council of Churches (WCC), worked hard in 2020 to educate, register, and empower voters across Wisconsin. In 2021, we have focused on building trust in the election, countering misinformation and disinformation, combatting voter suppression, and advocating for fair maps.

COVID-19 Response Pivots to a Broader Public Health Campaign


Wisconsin Faith Voices for Justice has been in the forefront of the battle against the COVID-19 pandemic, particularly working to address the disproportionate effect the virus and the subsequent economic fallout has had on communities of color. In the last year, our ongoing efforts have broadened to a campaign to create support for rebuilding our public health system and educating the public about larger issues of public health. Some of that work has included:



- Faithful Action for a Healthy Wisconsin: Our efforts to create a healthy Wisconsin has grown beyond COVID, as we have begun a campaign to change the narrative around health care, racism, and the social determinants of health, in partnership with UW Population Health and the Wisconsin Department of Health
- Our January monthly meeting of **Faithful Action for a Healthy Wisconsin** featured a presentation on messaging on the intersection of racism and health care disparities with experts from UW Population Health and DHS. We are working on short-term, mid-term, and long-term plans to change the narrative from health care as a function of personal responsibility to a broader look at the social determinants of health and the systemic racism that impedes people's ability to live healthy lives. Other meetings have educated us on the hazards of lead, mercury, and other contaminants in fish, as well as lead in water and paint
- We were invited and attended a reception at the Governor's mansion as a thank-you for our work on COVID-19 safety and the vaccine.

Racial Justice

➤ "Creating Beloved Community" weekly conversations continue with Wisconsin Council of Churches, WISDOM, and MICAH on how to combat white supremacy and galvanize clergy to raise their prophetic voices against hate. Our partnerships in this work have grown to include the Interfaith Conference of



Greater Milwaukee, the Wisconsin Council of Rabbis, and the Jewish Community Relations Council-Jewish Federation of Milwaukee.

➤ A thousand people have become involved with our **Taking a** Faithful Stance for Racial Equity movement

(https://www.facebook.com/FaithfulStanceforRacialEquity), signing our pledge (https://www.wichurches.org/2021/07/taking-a-faithful-stand-for-equity-making-a-commitment-to-civic-engagement/) and joining us at the monthly online meetings. These meetings have included a training on 501c3 do's and don'ts, a messaging training from All In Wisconsin's Race Class Narrative project, a talk by Casey Hicks at Conservation Voters on the importance of local elections, the impact on communities of color, and efforts to bring equity to our communities. We also focused on the necessity of building relationships with your local elected officials. On April 5, 2022, we

- organized a virtual Read-In of Dr. Martin Luther King Jr's Beyond Vietnam speech (https://www.youtube.com/watch?v=kECUWhdpgog&t=8s).
- ➤ Organized a response to a vote of the Cudahy school board's vote in July 2021 to reject their equity committee's recommendation on a new social studies text book. Because of our organizing efforts, we had six people speak in favor of the new textbook at the August board meeting, and the school board overturned their earlier vote and accepted the new textbook.
- ➤ On August 9, 2021, we held a prayer vigil at the state capital to raise the voices of the faith community to combat systemic racism https://www.facebook.com/118929964785730/videos/2844717512505566
- ➤ Testified to the Wisconsin Senate and Assembly Joint Education
 Committees in opposition to SB 411

 a bill that would have stifled educators' ability to teach the truth of our racial history in our public schools and universities
- Rabbi Margulis attended a vigil with CUSH, the Kenosha affiliate of WISDOM, during the Kyle Rittenhouse trial, and released a statement following the not-guilty verdict



- ➤ Latino Academy of Workforce Development served on task force to work on mission and vision as the Latino Academy becomes independent from its parent organization
- ➤ Rabbi Margulis spoke at Madison's annual Martin Luther King Day interfaith service sponsored by the King Coalition
- ➤ Our Creating Beloved Community coalition created our first annual Teach the Truth Wisconsin week of action to promote the honest teaching of our state and country's history of injustice toward communities of color, the LGBTQIA+ community, and religious minorities. Teach the Truth Wisconsin takes place the second week of October, which includes Indigenous People's Day and George Floyd's birthday. https://www.wichurches.org/2021/09/teachthetruthwisconsin-sites/
- Celebrated Black History month with an e-newsletter and a new page on our website that highlighted the achievements of the many women who helped lead the Civil Rights Movement.

The Dignity at Work Coalition

(http://www.dignityatworkcoalition.org/) is a coalition of faith groups, direct service organizations, advocacy organizations, and labor unions. We work together on issues that provide dignified labor that helps workers support their families.

- This year, we prioritized legal drivers licenses and state IDs for all, paid sick leave, and paid family leave.
- ➤ Updated our Voter Guide for Economic Justice for the new election cycle
- ➤ Represented by Rabbi Margulis at the capitol with Rep. Francesca Hong, Rep. Kristina Shelton, and US Rep. Marc Pocan on the reintroduction of the Economic Justice Bill of Rights
- ➤ Signed onto a letter to the Evers administration and the Department of Children and Families organized by Kids Forward on several problems with TANF and W-2, included a structural policy problem with the way they are administered
- > The steering committee completed ten months of Diversity, Equity, and Inclusion training
- > Sent a sign-on letter to Senators Johnson and Baldwin outlining three priorities we want to see stay in the Build Back Better legislation – paid leave, childcare, and elder care

The **Dane Sanctuary Coalition** is prepared to receive someone into sanctuary who is in fear of imminent deportation. We also engage in education and advocacy for immigrant rights, in partnership with Voces de la Frontera and Centro Hispano.

This year, we have:

- Continued our ongoing partnership with Voces de la Frontera in advocating for pathway to citizenship, drivers' licenses, and in-state tuition for DACA students,
- Recruit and train volunteers to drive immigrants to Chicago for immigration hearings and Milwaukee for ICE check-ins. Because COVID shut down the courts for over a year, requests for rides to Milwaukee and Chicago diminished. However, we began providing rides within Dane County for medical appointments and meetings with immigration attorneys. The courts are re-opening, and we are again getting requests for drivers. From January through June 2022, we provided over 25 rides.
- ➤ Sponsored a new Big Read *Separated: Inside an American Tragedy* by Jacob Soboroff, a gripping and in-depth look at how the U.S. policy of family separation has affected parents and children
- ➤ Sponsored a Big View *Living Undocumented* a documentary that follows the lives of eight families in the United States who are undocumented and facing deportation.
- ➤ Held a coalition-wide meeting on March 13, at which we heard from our immigration partners about their work and opportunities for engagement, donations, and volunteering
- Affordable housing and the cost of legal representation continue to be the highest priorities
- Housed an asylum-seeking family of five who arrived in Madison only to find their sponsor reneged on his commitment to house them. The Dane County Immigration office put them up in a motel for a few days, the Dane Sanctuary Coalition paid for three nights, and Plymouth UCC paid for a few days. They were able to find housing after that.
- ➤ Sent petitions to President Biden and to Wisconsin Senate and Assembly Majority leaders Robin Vos and Devin LeMahieu to advocate for a pathway to citizenship, assistance for refugees, legal driver's licenses, and in-state tuition
- Provided counseling and monetary assistance to a new mother in Appleton whose partner had been taken by ICE
- ➤ Participated in planning and outreach with Voces de la Frontera to get Madison folks out to Day Without Latinx and Immigrants in Milwaukee May 1 and to lobby day in Madison May 2



Clergy Organizing

WFVJ sponsors two interfaith clergy councils – the Greater Milwaukee Faith Voices for Justice, and the Multifaith Coalition of South-Central Wisconsin. 
GAILDEN MOORE
